##### **1. Discussion Item: Resolution in Support of SB 995 (Time Certain = 3:15 PM)**

We will be going through another reading of the resolution with changes made from the feedback of the last meeting in support of SB 995 which is introduced by Senator Padilla and it proposes a pilot program in California to address teacher shortages by creating a pathway for students at California Community Colleges (CCC) to earn a teaching credential and bachelor's degree through resources from the California State University (CSU) system. This collaboration between CCC and CSU aims to attract high-quality teaching candidates and also reduces financial and time barriers to obtaining a credential, and ultimately mitigate California's teacher shortage, which has led to unqualified staff hires due to the 59% decline in CSU teacher credential program enrollments from 2003 to 2022.

SB 995 builds upon AB 928, which aimed to streamline transfers from CCC to four-year institutions, by focusing specifically on the teaching credential process. It has garnered support from the California Teachers Association, educational institutions, and ASCSUS, which advocates for its reintroduction in the 2025-2026 legislative session and recommends support from the Sacramento State Faculty Senate.
