Course Requirements and Assignments

Quizzes (4) – Enhance your learning of the Module’s topic by reviewing key information in the assigned materials for that Module. These are open-note and open-book.(CLOs 1 – 4)

Discussion Posts (10) – Critically evaluate and debate current events highlighting unequal treatment (e.g., police brutality) with your fellow students on the class discussion board. (CLOs 2 – 5)

Caste Project – Individually or with a partner, construct a narrated slide show presentation that summarizes a chosen aspect of the American “caste system” (CLOs 1 – 5)

Book Journal – Answer a series of questions about the socio-legal construction of race as you read the book, *White by Law*. (CLOs 1 & 2)
